2.1. Classification of the substance or mixture

Long-term inhalation of ambient air heavily loaded with dust and fumes can affect the health of workers.

The operations mentioned above must be carried out in a well ventilated environment. The main risk of exposure is inhalation. (Inhalation of solder fumes)
